Terms and Conditions

Promoter	Carlton Football Club Limited (ABN 95 005 449 909), IKON Park, Royal Parade, Carlton North, VIC 3054 (Promoter or Club).
Promotion Period	9:00am (AEST) on 20/07/2026 to 11.59pm (AEST) on 23/08/2026.
Who is eligible to win?	Entry is open only to 2026 financial members of the Club who are Australian residents (Members). Entrants under the age of 18 must receive parental or guardian consent to participate. If a winner is under 18, the prize will be awarded to their parent/guardian on their behalf.
Who isn't eligible to win?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this promotion.
Which matches does the promotion apply to?	The promotion is being run in relation to the Club's following AFL matches: (a) Round 20 vs Gold Coast at Marvel Stadium on 25 July 2026; (b) Round 21 vs Brisbane at Marvel Stadium on 1 August 2026; and (c) Round 24 vs Gold Coast at Marvel Stadium to be held on the week commencing 17 August 2026 (exact date TBC), (each a Match and collectively, the Matches).
Promotion mechanics	Members will be automatically entered by the Promoter into the promotion when they do any of the following in relation to any of the Matches: (a) scan in – scan their membership card or mobile pass to attend; (b) upgrade – upgrade their member ticket to a reserved seat; (c) forward – forward their member ticket to another person who attends the relevant Match/es in their place; and/or (d) return – return their reserved seat via the Club's official seat return mechanism so that another fan can purchase it.
How many times can I enter?	Members may be entered into the promotion up to a maximum of three (3) times, once in relation to each of the Matches. Each entry must be submitted in accordance with these Terms and Conditions.
How many winners will there be?	There will be two (2) winners selected.
What do the winners win?	There are two (2) prizes available (1 prize per winner). Each winner will win \$5,000 cash, to be deposited via EFT into each winner's nominated Australian bank account.
Total prize pool	The total prize pool is \$10,000.
